## FROM OUR PRESIDENT, MIKE MALONEY REBIRTH OF OUR MOUNTAIN COMMUNITY

Following the lead of a recent editorial in the Chico ER, I found myself inspired to convey this message about the state of our special mountain community. The editorial spoke of a particular event which had sat dormant/ "forced to the sidelines" for a time because of Covid. This prompted reflection with me about what has been happening up here the last few years. Specifically, since 2018 we have experienced impact from the Camp Fire, Covid, the Dixie Fire and most recently, Snowmageddon! These events have caused disruption to mountain life as we had previously known it. We were forced to flee and/or to be locked down in our homes; we were forced to leave our mountain homes with the possibility they may not be there when we returned; we were precluded from patronizing local businesses and from participating in traditional formal and informal community events; socialization was profoundly curtailed; and the recent weather-related impacts caused all kinds of isolation and even damages from which we are still recovering. While all this was happening, life continued to go on. In some cases we gained new friends and neighbors, and in other cases we lost community icons. The result of all of this is that life on the mountain has changed, and will hereafter be different. My hope for all of us is that as we move forward from here with our new sense of life in Butte Meadows and Jonesville, we remember our great history, we remember our friends who have left us and we embrace the opportunities we have to come together as a community to experience and enjoy our outdoors and our company as we always have!

## *Emergency Preparedness*

There are two 911 Emergency Phones in the Butte Meadows / Jonesville area: at The Bambi Inn on the front porch and at the Jonesville Snow Park on the outside wall of the equipment shed. The phone at the volunteer fire station is no longer connected.

There are two AEDs (Automated External Defibrillators) located at the Mercantile and one at the Jonesville Hotel for CPR emergencies.

There are 3 First Aid Bags stocked with a good supply of items for use by anyone in the area who is responding to an emergency. The bags are located at the Bambi Inn, the Mercantile, and Jonesville Hotel located at 7553 Humboldt Road.

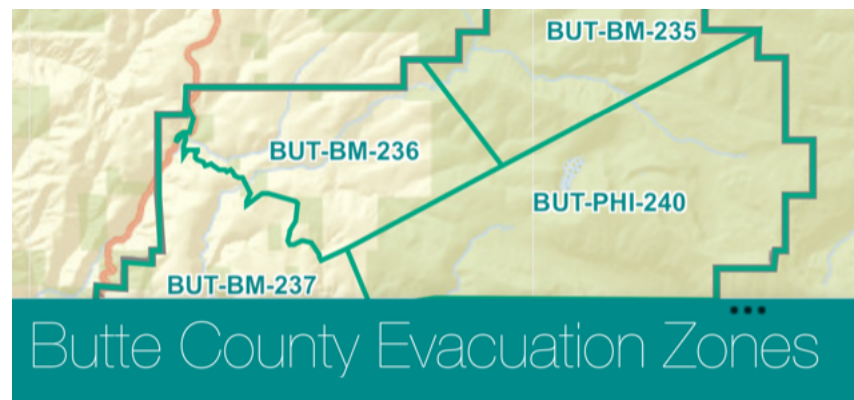
The safety water wagon is housed at Liz's garage next to the Outpost from November 1 to April 31. From May 1 to October 31 it is on Bob Wessels' property.

**The Outpost** - The only news on the Outpost, per one of the new owners, is: The Outpost is in need of lots of TLC, the weather has not been their friend and they will finally be up in the next week or so. We will be seeing them around. No information about any specific plans at all or any projected timelines.

## Evacuation Zones

Did you know that the entire county of Butte has been divided into specific zones for purposes of evacuations or responding to other emergencies? If you want to know where all the zones are, and how they are identified, you can just Google "Butte County Evacuation Zones, and a handy link should come up. Separate from that, the zones for our little corner of the west are as follows:



- Lower Butte Meadows/Lomo Area = ZONE 237
- Central Butte Meadows from approx. Station 11 to Cherry Hill = ZONE 236
- Jonesville to Plumas and Tehama county lines = ZONE 235
- Philbrook area = Zone 240

## Green Waste

Green waste events are coming up!! The fall green waste event will be October 14 and 15. It should be noted that in the past, payment for the green waste dumpsters has been supplemented by grants from the county. For a variety of reasons, those grants are no longer available to us. Therefore, BMJCA would gladly accept and appreciate any donations from the community to off-set the thousands of dollars of expenses related to this community event. Also, the county has several designated days for residents in the wild-land urban interface (we are) to drop off their green waste for free at the Neil Road Landfill (see attached schedule).

# Enloe FlightCare Membership Program

## Statement of understanding

For complaints regarding Enloe FlightCare Membership Program, call us at (530) 332-6774. If we fail to resolve the complaint to your satisfaction, contact the Department of Managed Health Care at (800) 400-0815. The Department's website is www.dmhc.ca.gov. You may obtain complaint forms and instructions online.

Enloe FlightCare is operating pursuant to an exemption from the Knox-Keene Health Care Service Plan Act of 1975 (Health and Safety Code Section 1340 et seq.).

## Before you purchase

If you are currently in a health maintenance organization (HMO) or other health insurance, the benefits provided by an air ambulance plan may duplicate the benefits provided by your HMO or other health insurance. If you have a question regarding whether your HMO or other health insurance offers benefits for air ambulance services, you should contact that company directly.

**WARNING:** The Enloe FlightCare Membership Program is not an insurance program. It will not compensate or reimburse another ambulance company for providing emergency transportation to you or your family. This may occur when the "911 Emergency System" has independently determined that another company could provide more expeditious service or is next in the rotation to receive a call. This might also occur when Enloe FlightCare is unable to perform within a medically appropriate timeframe due to severe weather, a maintenance issue or being committed to another call.

## Statement of understanding

- I understand Enloe FlightCare Membership Program benefits are for myself, my spouse and dependents (those claimed on my income tax forms) listed on this form for the type of membership indicated.
- I understand that Enloe FlightCare benefits only apply when an Enloe FlightCare member is transported by Enloe FlightCare or a reciprocating program.
- I transfer, directly to Enloe FlightCare, my rights to air medical insurance payments due me. Such payments shall not exceed FlightCare's regular charges. Enloe FlightCare will respond based on medical necessity only. Medical necessity must be determined by a health care professional, a pre-hospital health care provider, or a third party recognized by FlightCare (excepting cases of extreme remoteness).
- New member benefits take effect three days after receipt of a completed application with payment.
- Enloe FlightCare membership fees are non-refundable and the membership is non-transferable.
- I understand the FlightCare program or the FlightCare Membership Program may be canceled at any time for any reason.
- I understand my membership is not an investment, and does not provide any form of financial security or any form of insurance to me, my spouse, or dependents. I understand that the primary purpose for my membership is to support FlightCare and local community emergency medical services. I specifically waive any and all rights, claims or causes of action against Enloe Medical Center, its employees and agents with respect to my FlightCare membership and the FlightCare Membership Program.

**I understand that Enloe FlightCare will be used only for medically appropriate transports and that Enloe Medical Center will bill a member's insurance plan, if any, but will not bill the member-patient for any remaining balance.**

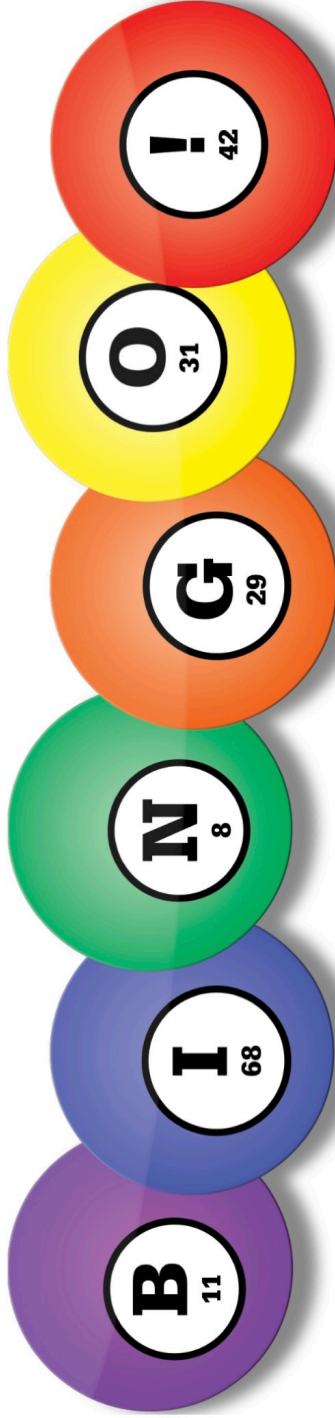
